NOTICE TO THE RENTER/PARTICIPANT

Participation in any watersport may expose you to certain inherent risks and dangers. Accidents and injuries (superficial to fatal) resulting from any number of causes including, without limitation, inclement weather, other boaters (both power and sail), unseen obstacles, fatigue, and your own misjudgment are a very real possibility. By signing this waiver and liability agreement, you acknowledge and accept that you are willingly and voluntarily participating in a potentially dangerous activity that may result in personal injury or death.

Great Lakes Waterman Inc. ("GLW") considers safety to be its utmost concern and, as such, its staff includes individuals trained in life-saving, water-safety, first aid instruction. The nature of watersports, however, makes it impossible to foresee and protect you from all conceivable risks and dangers associated with water and watersports. Once you leave the safety of the shore and enter the water, you must be prepared to assume all risks associated therewith.

YOU CERTIFY THAT YOU HAVE READ THE FOREGOING NOTICE PRIOR TO THE SIGNING HEREOF AND FURTHER CERTIFY AND AGREE AS FOLLOWS:

1. I hereby affirm that I understand and accept the inherent risks and dangers of E-Foiling, Kiteboarding, Windsurfing, Kayaking, Stand-up Paddle Boarding (SUP), and Sailing.
2. I hereby agree to indemnify and hold harmless GLW and its staff, and any related companies, from any and all liability for any harm, injury, death, or damages (physical, mental, or monetary), regardless of fault or negligence, which may befall me while participating in this program or while using GLW equipment and facilities. This release shall be binding upon me, my family, heirs, and administrators.

3. I hereby certify that I am a proficient swimmer and have experience participating in watersports.

4. I hereby agree to heed at all times the advice and instructions of GLW staff and to practice common sense water safety procedures.

5. I acknowledge and agree that no representation, undertaking, warranty, covenant, or other commitment of any kind is made nor shall it be deemed to be made, whether express or implied, regarding GLW, its employees, agents, officers, directors or shareholders or any affiliated entity, with respect to any goods or services or instruction provided by GLW, and none of such parties shall incur any liability whatsoever, irrespective of how liability arises, including any property damage, injury or loss of life whether sustained personally or by third parties, while participating in GLW watersports.

6. I freely and voluntarily waive all claims for damages or loss to my person or property, or the person or property of any third parties, that may be caused by an act, or failure to act, of GLW or its employees, agents, officers, directors or shareholders or any affiliated entity.

7. If the Renter/Participant is under 18, the person signing as parent/guardian acknowledges and agrees to the foregoing.
